### Release of Liability and Assumption of Risks

I agree to limit the liability of Lance and Kirsten Gray (including their officers, employees, subcontractors, agents, and guides) arising from any and all causes. The limitation of liability applies even in cases of negligence, recklessness, strict liability, breach of contract, or any other act or omission on the part of Lance and Kirsten Gray. I recognize that I am providing limited financial rewards to Lance and Kirsten Gray and do not intend to expose Lance and Kirsten Gray to disproportionate financial risks. I recognize that other businesses provide services to Lance and Kirsten Gray and that I would have used another business if I had any reservation whatsoever with this limitation of liability.

My participation is purely voluntary and I elect to do so at my sole risk.

I understand that fishing and related activities (hiking, wading, boating, etc.) are inherently dangerous and risky. These dangers and risks include, but are not limited to: drowning, lacerations, broken bones, insect and animal bites, stolen and damaged equipment, heat stress, hypothermia, and inclement weather. I accept and assume these dangers and risks and will not hold Lance and Kirsten Gray responsible for any costs, liabilities, injuries, damages, etc. associated therewith.

I will be solely responsible for my transportation to and from the designed meeting location. If I choose to compromise safety during my transportation (such as driving after a long and tiring day of fishing), I do so at my sole risk. If I choose to ride in a vehicle operated by a Lance and Kirsten Gray representative, I will indemnify, hold harmless, defend, and protect Lance and Kirsten Gray (including their officers, employees, subcontractors, agents, and guides) from and against any and all costs, injuries, and liabilities (including third party claims and reasonable attorney's fees) associated with my being a passenger. I acknowledge that Lance and Kirsten Gray's representatives are not authorized to operate vehicles for hire.

I understand that fishing activities may be strenuous and may require physical skills that I do not possess. I recognize that it is my responsibility to set my own pace and adjust for my own limitations. If I choose to participate in the fishing activities without the requisite swimming skills, I do so at my sole risk.

Limited safety equipment such as a life vest, wading belt, and wading staff will be provided by Lance and Kirsten Gray upon request. I do not expect Lance and Kirsten Gray to specifically offer these to me and if I choose not to request these items, I do so at my sole risk. If I choose not to use these items, I do so at my sole risk.

I understand that fishing and related activities typically occur in remote locations with limited access to first aid and emergency response. I will be responsible for my own medical attention and costs. I understand that Lance and Kirsten Gray do not carry first aid supplies.


